# [DRAFT EMERGENCY] RESOLUTION ON ALLEGATIONS OF SEXUAL MISCONDUCT AGAINST FORMER CALIFORNIA DEMOCRATIC PARTY CHAIR ERIC BAUMAN

WHEREAS the allegations of sexual harassment, sexual assault, and witness intimidation against former California Democratic Party Chair Eric Bauman are deeply disturbing to Democrats everywhere; and

WHEREAS the personal accounts of those who've come forward to tell their story have been heartbreaking and the conduct they describe violates core Democratic Party values, including respect for the right of all to be free from harassment and abuse, especially from those in positions of power; and

WHEREAS Mr. Bauman has resigned his position as California Democratic Party Chair, initiating a process of interim succession under the Party's Bylaws, while victims have continued to come forward to tell their stories and all victims require ongoing protection and support;

THEREFORE BE IT RESOLVED that the Santa Clara County Democratic Party supports and stands with all victims of harassment and abuse calls on the California Democratic Party to ensure the previously-announced investigation of the allegations against Mr. Bauman by an independent law firm is comprehensive and considers fully the adequacy of the organizational response to information about potential misconduct, including underlying offenses and witness intimidation; and

BE IT FURTHER RESOLVED that the Santa Clara County Democratic Party calls on the California Democratic Party to protect and support those who have spoken out, while also encouraging others who may have experienced misconduct to come forward, so that they can receive assistance and resources.

## Proposed Bylaws Amendment to Create Youth Represenative

Insert the following after Section II.A.6, renumbering current II.A.7 and II.A.8 to be II.A.8 and II.A.9, respectively:

II.A.7. Youth Representative: One member, elected as described below in Article IV, section C. To be eligible to serve as Youth Representative, a person must 16 to 22 years of age, must reside in Santa Clara County, and must be registered or preregistered as a Democrat.
