a. Resolution for open source elections- County Pledge (See Back)

Brent Turner from San Mateo County Central Committee elections committee spoke on behalf of advocating for more transparent elections. Recommending that Registrars to get open source, County-owned system. SF County first Bay Area county that will join this cause.

Questions: Are you considering a board that will oversee these transitions?

Answer: Yes. SB 360 would allow state to self-certify elections system.

Concerns: Don't want Santa Clara County would create own system.

Answer: Work would be done through Sec of State with universities and other entities.

Pearl: Suggests that a group or committee look at the wording outside the meeting to craft better wording.

Discussion

Engstrom: Suggests amendments to allow for approval voting.

"Approval votes must be cast on paper ballots"

Endorsed"All candidates receiving 2/3 of the vote gets endorsement". "If two or more candidates get 3/5, they shall be endorsed."

If no candidate gets 2/3 or 3/5 vote, they shall NOT be endorsed.

Amendment moved; seconded; discussion

Edwards: Does not agree with multiple endorsement for one race.

Engstrom: Approval voting helps alleviate some problems in endorsement process; voting by hand causes discrepancies. Approval voting creates a paper trail.

Bill: Opposes amendment. Would create unintended "NO ENDORSEMENT" and unintended "SOLE ENDORSEMENT". Changes outcomes through procedure.

Engstrom: This doesn't eliminate anything; it creates a choice. No perfect voting procedure, but it gives us a choice.

Chessin: "Later No Harm" (second preference shouldn't harm your first preference). We cannot have secret ballots.

Madrelejos: Concerns- 1. Candidates seeking endorsement need to know what our process is. 2. Choosing best candidate in the particular race.

# RESOLUTION FOR OPEN SOURCE ELECTIONS- COUNTY PLEDGE

WHEREAS, public confidence in the integrity of the election system in the United States is declining; and voting machines and the computers that add vote totals are being run with computer programs or software that can substantially change vote totals in subtle ways that are difficult to detect; and

WHEREAS, we the people have the right to know exactly how votes are processed, to have transparent elections, and to have computer scientists analyze open source code for malicious code which could be used to manipulate elections; and

WHEREAS, proprietary computer software denies us this right to know, inner workings of the computerized vote counting hardware are secret; and there are now better methods available under the passage of SB-360 that will heighten transparency and increase security while reducing costs and

THEREFORE BE IT RESOLVED, that the Santa Clara County Democratic Party calls upon Santa Clara County and the San Clara County officials to pledge available resources toward the effort to create, certify and deploy publicly owned, open source election systems.

BE IT FURTHER RESOLVED, that copies of this resolution should be distributed to the California Democratic State and Federal delegation as well as the State's Democratic State Constitutional Officers.
