Resolution Urging State and Local Governments to Remove Illegal and Unenforceable Racially Restrictive Covenants from Real Estate Transaction Documents and Processes

Whereas, in the State of California every year, thousands of real estate transactions continue to be conducted using deeds, titles, and other documents that contain race restricting covenants that prevent transfer(s) of property to racial, ethnic, or religious minorities, but frequently black people; and

Whereas, the US Supreme Court ruled in Shelley v. Kramer (1948) that racially restrictive covenants were unenforceable, illegally violated the Fair Housing, and state (or local) enforcement of such covenants violated the Equal Protection Clause of the Fourteenth Amendment; and

Whereas, the continued inclusion of these covenants in real estate contracts perpetuates a discriminatory housing practice against people of color and religious minorities by both discouraging the transfer of property and artificially reducing the supply of housing available to them; and

Therefore be it resolved, that the Santa Clara County Democratic Party urges Santa Clara County and local governments to act to completely remove racially-restrictive covenants from the real estate transaction process; and

Be it further resolved, that the Santa Clara County Democratic Central Committee will send copies of this resolution to members and bodies of local governments within Santa Clara County.
