Resolution Removing the Santa Clara County Democratic Party Endorsement of Gilroy City Council Member Fred Tovar

WHEREAS Gilroy City Council Member Fred Tovar's policy positions are in direct conflict with the platform adopted by the Santa Clara County Democratic Central Committee, such as Tovar's positions opposing sustainable principles into land use, development, housing, and transportation policies; voting against the climate actions for the construction of new buildings that are all-electric; voting against renter protection; and opposing projects that bring below market rate housing; and

WHEREAS Tovar's voting history has harmed the residents and employees of Gilroy by opposing policies that foster transit-oriented development, such as: increased intensity/density along transit corridors and stations, affordable housing in transit corridors, mixed-used development, subsidies to encourage transit use, unbundled parking, and complete streets; and

WHEREAS Tovar's repeated endorsement of Republican candidates when qualified Democratic candidates have entered the race and present a Democratic alternative undermines our Democratic Party platform and values;

THEREFORE BE IT RESOLVED that the Santa Clara County Democratic Party removes our endorsement of Gilroy City Council Member Fred Tovar.
