## Proposed Changes to SCCDCC Executive Board

Proposal to create the position of Political Director, assign to the Political Director all duties currently assigned to Campaign Services Director and certain duties of the Director of Endorsements, and convert Director of Endorsements to an Endorsement Committee Chair.

### Proposed Changes to Bylaws Article IV Section B:

Change IV.B.3. to read "Political Director" and delete IV.B.5 (re Director of Endorsements).

## **Proposed Changes to Endorsements in Local Races Act:**

- i. Change reference in I.B. from “Director of Candidate Recruitment and Endorsements” to “Endorsement Committee Chair”
- ii. Change reference in I.A. from “Director of Candidate Recruitment and Endorsements” to “Political Director”
- iii. In II.A., add a provision for the County Chair to appoint “An Endorsement Committee Chair (or Co-Chairs) appointed by the County Chair and approved by the Executive Board.”
- iv. Change reference in II.A.4 from “Director of Candidate Recruitment and Endorsements” to “Political Director”
- v. Change references in II.B. from “Director of Candidate Recruitment and Endorsements” to “Endorsement Committee Chair”
- vi. Add II.A.5 designating County Chair and Political Director as ex officio (voting) members of the Endorsement Committee
- vii. In II.G., change “Director of Candidate Recruitment and Endorsements” to read “Endorsement Committee Chair” and “Director of Campaign Services” to read “Political Director”
- viii. Change in III.E.1. from “Director of Candidate Recruitment and Endorsements” to “Political Director”
