- 1. Attended DNC Meeting in St Louis MO in October
 - Highlights from October
 - 26 Resolutions presented 24 passed
 - resolutions including supporting Biden/Harris for re-election;
 - Making SC as first state for the Presidential Primary;
 - Full Support for Ukraine defense;
 - condemn Republican extreme Anti-Choice; Foreign Affairs;
 - DC and Puerto Statehoods;
 - antitrust laws (Thx to the Swifties), Universal free school meals;
 - environmental noise pollution; etc.
 - Separately, Otto got appointed to serve on the DNC Credentials committee

November updates:

- 2. Attended Democrats Abroad Meeting first regional meeting since 2019
 - Pre Meeting in Barcelona; Oct 27-29 in Alicante, attended by DNC member labor leader Larry Cohen, founder of OUR REVOLUTION with Sen. Bernie Sanders
 - Items to be aware of 9M American Citizens living abroad, over 6M are eligible voters, but only 1 M voted in 2020
 - O Retired and living part time oversees, Military, Students studying abroad
 - Challenges in casting votes due to different laws for every state for getting overseas ballots in, and counted last in many counties;
 Republicans are about making voting harder...
 - Overwhelming overseas votes, over 90% vote Democrat.
 - Huge potential for getting more votes in 2024 in all 50 states
 - Voter outreach near military bases is important GA runoff outreach project focusing on 30 mile radius of military bases in GA with record turnout of those areas
 - Misconception that military members are Republican voters but in reality, especially enlisted members are more liberal and moderate leaning now with Trump denigrating Senator John McCain ("I like people who weren't captured"), and insulted the general that served him like Chair of Joint Chiefs of Staff, General Mark Milley, his Chief of Staff Marine General John Kelly, and SecDef Marine Corps General John Mattis, Tuberville fiasco hated even by his fellow Republican Senators, most military votes are NOT going to Trump DNC CONVENTION in Chicago August 2024

Those wanting to run for delegates for the 2024 DNC Convention – the election will be held via Congressional districts and dates/times TBD with the Regional Directors that will be organizing those elections.
